EPA understands that the purpose of this assignment is to facilitate the acquisition by the DRG Pennbrook Tenants in Common of a portion of the North Penn Area 7 Superfund Site, 1180 Church Road Facility (Property) for the purpose of using the buildings on the portion of the Property as offices in conformity with Section I (Introduction) of the PPA. The portion of the Property that the DRG Pennbrook Tenants in Common intend to acquire is Unit I of Pennbrook Business Center Condominium.

EPA finds that the assignment to the DRG Pennbrook Tenants in Common of all rights, benefits and obligations conferred by the PPA with respect to the portion of the Property being acquired by the DRG Pennbrook Tenants in Common is in keeping with the goals of the PPA. Therefore, pursuant to paragraph 26 of the PPA, this letter will serve as EPA's written consent to this assignment. DRG Pennbrook Tenants in Common must notify EPA of the effective date of
